## Application Guidelines

### Eligibility

- Open to artists of all nationalities and ages that are not under exclusive representation by gallery.
- No restrictions on content, form, or medium.

### Organizers

- Supervising Authority: Taiwan Ministry of Culture
- Organizer: Fun Year Art Gallery
- Exhibition Venue: B1, No. 16, Lane 301, Section 2, Henan Road, Xitun District, Taichung, Taiwan 407

### How to Apply?

- Submit via Google Form.
- Required materials:
  - Personal Information (including contact details, education, exhibition history, and awards).
  - Artwork Details (title, medium, dimensions, year, and artistic statement).
  - Upload 3-5 representative works.
  - Once submitted, applications cannot be modified.

## Application Timeline

- **Submission Period:** April 1, 2024, 00:00 – May 18, 2024, 24:00
- Late or incomplete applications will not be accepted.
- Notification of Selected Artists: May 23, 2025, via email (only selected artists will be notified).

## Selection Process

- A panel of professional judges will evaluate applications based on artistic merit.
  - The organizer reserves the right to leave positions unfilled if necessary.

## Exhibition Details

- **Exhibition Period:** June 13, 2025 (Friday) – July 12, 2025 (Saturday)
- **Display Arrangement:** The gallery will allocate exhibition space for selected works.
- **Withdrawal Policy:** If a selected artist is unable to participate, the spot will be offered to a waiting list artist.
- **Submission of Exhibition Materials:** Selected artists must submit all required materials (artwork images, details, artist biography, statement, and price list) within 7 days of notification.

## Installation and Deinstallation

- Artists are responsible for transportation and installation & deinstallation of their works.

## Sales and Commission

- Artworks will be available for sale during the exhibition.
- **Sales Commission:** 50% gallery commission, 50% to the artist.
- The gallery holds exclusive sales rights during the exhibition period.
